


## **Ottawa Update**


- Case counts are decreasing in the community and in LTCHs
- Deaths per week decreased from last week
- The number of ongoing outbreaks is stable
- Over 90% of cases are reached within 24 hours
- New hospital admissions in Ottawa hospitals or ICUs with COVID-19 is stable
- PPE supply is adequate for 2 weeks
- Ottawa laboratory testing capacity is being maximized

## Infection Prevention & Surveillance Testing

 Infection, Prevention and Control (IPAC) measures are essential

on offer

- Staffing supports contributed by hospitals, including for cleaning, are making a difference in LTCHs in the worst situations.
- Testing in Ottawa's 28 long-term care homes and of staff in 3 emergency childcare centres planned to be completed by May 15.
- Ministry has not directed to expand testing to other settings, however work is underway in Retirement Homes in need.



## **Supporting Congregate Care**









#### Preparedness and Prevention:

- Providing information on PPE use and access, screening, enhanced IPAC measures, physical distancing
- Customized guidance documents
- Relocating residents out of shelters
- Rooming House Task Force

#### Outbreak Prevention and Management:

- Identifying and isolating symptomatic individuals
- Providing accessible screening and testing
- Supporting the self-isolation of residents and isolation centres

## **Expanding Testing**

- Expanding capacity to test every person in Ottawa with COVID-19 symptoms:
  - Common Symptoms: feeling feverish, cough, or difficulty breathing
  - Less common symptoms

- New or worsening respiratory symptoms
- Continued Brewer Assessment Centre Testing:
  - 94.6% of people seen were tested (total of **15,222** tested)
  - 56.9 % of total tested were Health Care Workers (total of **8,055** tested)
- East and west Care Centres: 2,333 tested




## **Looking Ahead – Recovery Phase**

### What We've Heard

- 1472 residents engaged, 8381 site visits
- >90% plan to continue practicing physical distancing as restrictions are eased
- 90% would be willing to wear non-medical masks in public in order to access service
- Park closures, reduced family/social connectedness, physical distancing requirements and school/childcare closures have been especially difficult
