What is the Current COVID-19 Situation?

- Case counts stable
 - Just less than half with no known exposure
- Hospitalization decreasing
- Outbreaks still occurring
- Case and contact follow-up on target
- Testing volumes steady, percent positive down




Learning to Live with COVID

- Monitoring and adapting to any resurgence
- Adapting testing, case & contact management
- Supporting communities that have greater needs
- Scenario planning



Transmission Stays Manageable

 First "wave" followed by low level transmission for 1-2 years

a 000

- Manageable for health care system
- Requires being COVIDWise, community supports
- May be able to widen social circles, increase gatherings, limit restrictions over time




Regular Increase That Needs Addressing

 Series of ongoing periods of resurgence for 1-2 years

- Peeks could require periodic increase in restrictions, limits to contacts
- Need to continue to be COVIDWise and support communities




Large Resurgence Requires More Restrictions

- First wave followed by high and sharp resurgence of cases
- Seen in other countries

a 000

- May affect healthcare system function
- Could require a return to more restrictions, limits
- Need to continue to be COVIDWise and support communities



Masks are Another Layer of Protection


Rationale

0000

- Asymptomatic/presymptomatic spread
- Re-opening businesses & resuming activities increases risks of resurgence
- Growing community acceptance and support from the business sector

Evidence

- Various studies, emerging evidence
- Experience from other jurisdictions
- Consistent recommendation



Joint recommendation – OPH and By-law and Regulatory Services

Report recommendation:

"That Ottawa City Council approve the Temporary Mandatory Mask By-law, as attached at Document 1 and as described in this report."

By-law Requirements

- Every person who enters or remains in an enclosed public space is required to wear a mask that covers their mouth, nose, and chin
- Every operator of an enclosed public space is required to notify patrons of the mask requirement through signage and verbally
- Every operator of an enclosed public space is required to provide alcohol-based hand rub to patrons at entrance and exits

Exemptions to the By-law:

000

- Young children, persons with medical conditions or disabilities that prevent them for safely wearing a mask, persons who are unable to put on or remove their mask without assistance, persons engaged in specific activities such as swimming or physical exercise
- Employees are required to wear a mask when in a public area of the building except when behind a barrier such as a plexiglass

Enforcement

By-law and Regulatory Services (BLRS) will administer and enforce the Temporary Mandatory Mask By-law while it is in effect

Enforcement Approach

- Educate and inform to gain voluntary compliance
- Enforcement and penalties through tickets, if necessary
- Enforcement of this by-law and other regulations within BLRS' By-law and Regulatory Services' purview may vary based on demand for service
- Service Requests related to this temporary by-law will be treated as a priority call for BLRS

Fines and Enactment

- Requested set fines will be a reasonable amount, consistent with other City by-laws
- There will be set fines for individuals and for Corporations, should it be deemed necessary to issue charges

Enactment and Repeal Date

 Proposed by-law is temporary – takes effect immediately when passed by Council and remains in effect until the next Council meeting (August 26th); Council may then extend it if necessary for public health objectives, with advice from the Medical Officer of Health
