Councillor's Report



Hunt Club Community Association March 1, 2021

RIVER WARD PARKS

McCarthy Park Basketball Court

I have had recent meetings with Parks and Recreation staff on two types of designs for the new McCarthy Park basketball court.

The court will be erected where the current boarded skating rink is and will not impact winter skating.

Two design options:

- Would permit two small, east-west courts, cost \$175,000
- 2. Would permit one north-south regulation court, with removable posts, cost \$180,000

Both options include LED lighting upgrades, however, a photometric study will be conducted and may demonstrate the LED upgrades are insufficient for basketball lighting, as such, additional funding would be required to replace the light poles and fixtures.

There is no infrastructure in place for the existing court, this would remain unlit.

Parks and Recreation recommend Option 2. I am seeking input from the HCCA.

In addition to the basketball court, I will be meeting at the end of this month with several Hunt Club residents to discuss amenities in McCarthy Park and brainstorm gardening and beautification opportunities, as well as community survey options.

Uplands Park Naming Working Group (WG)

On February 23, I met with members of the Uplands Park Renaming Working Group. Our discussions continue and another meeting will take place at the end of March to consider an additional round of potential names. There is interest in naming the park after a woman with a local connection. We also discussed the value of placing an information plaque in the park to share the story behind the Uplands name in order to preserve its local and historical significance.

The Working Group also acknowledged the multiple contributions to the local community by John Sankey and

believes a commemorative naming in his honour is warranted. I will discuss options with the Chair and Vice Chair

LOCAL INFRASTRUCTURE

Telus Fibre Optics Status

Telus contractors are nearing completion on Uplands Drive, from Riverside Drive to Hunt Club Road, where they have been installing conduit and manholes, and pulling fibre to service the Telus mobility tower on the roof of 3360 Paul Anka for the 5G technology rollout. Work began Jan. 18 and they are now 80 percent complete. There is approximately 400 metres left to build and the project supervisor is hoping that will be done by the end of this week. Crews would then return the following week to pull the fibre through the new conduits. I have been assured there will be no construction during this stage.

Bell Fibre Project Coming

Bell Canada has applied for City permit approvals to install fibre to residential homes in Hunt Club. Fibre is said to be much faster and more reliable than copper services. The work will include directional boring, open trench work when required, and the placement of new Bell pedestals, conduit and wire along Hunt Club Place, Hunt Club Road, Boone Crescent, Lillico Street, Erin Crescent, Lillico Drive, Uplands Drive, Bennett Street, Sample Road, Paul Anka Drive and Royal Hunt Crescent.

The project would include placing service drops using a 10-inch trench line for minimal damage to provide fibre services to homes. I have been assured that I will be updated by the construction manager weeks before any work begins. City approvals have not yet been granted.

Hydro One Transmission Project

Hydro One's transmission line upgrade is planned to begin in early 2022. This is the line that runs East-West just north of the train tracks across McCarthy Road. They anticipate securing approval of the project from the Ontario Energy Board in the second quarter of 2021. I also want to host a

community meeting, either virtually or in person depending on public health guidelines, at the end of 2021 before construction begins. I will keep you informed about that engagement session. I have shared an information flyer of this work with your President, Vice-President and Corporate Secretary and will provide a copy to anyone on request.

Hydro One Vegetation Maintenance

Hydro One has completed the vegetation maintenance work it needed to do in 2021 along the hydro corridor from Riverside Drive towards Hunt Club Road. The work involved removing or trimming trees and other vegetation in the corridor that were identified as posing a risk to the electrical infrastructure now and in the future. Crews are scheduled to return to remove two tree stumps along Lillico Drive this year when ground conditions improve. The exact timeline for this has not been determined.

Rideau River Multi Use Pathway Detour

I had a constructive meeting last week with LRT Phase 2 Senior staff & Councillor Shawn Menard regarding the planned MUP detour along the Rideau River where the new pedestrian/cyclist bridge is to be built. We reviewed other options that will provide greater safety and will reconvene this week to continue the discussion. I have heard the concerns from the pathway users and am working with staff on finding a solution.

CITY UPDATES & CONSULTATIONS

Bylaw Enforcement

I recently met with the head of Ottawa's Bylaw and Regulatory Services to discuss enforcement in school zones. There have been significant traffic issues in school zones across the city with more parents and guardians driving their children to and from school. The department's parking operations unit is facing record demand, especially when coupled with their previous redeployment for COVID enforcement. As well, they are fielding higher call volumes related to school zones where there has been an upswing in traffic. Still, school zones are a focus area for bylaw officers. The director assures me that tickets are being issued as there is zero tolerance for school zone infractions.

Interim Tax Bill

The interim property tax bills will be mailed out to residents between February 22 and February 26, with taxes due on March 18, 2021. The interim tax bill is the first tax installment for the year and represents 50% of the previous year's taxes. Residents and businesses financially affected by the pandemic can find support available to them from the provincial and federal governments on Ottawa.ca/taxes.

Survey on Residential Vacant Unit Tax

On December 9, 2020, City Council approved a motion that directed staff to study the authority to impose a tax on vacant residential units and report back by the end of Q2 2021 on the feasibility of such a tax.

The City has created a survey on the Engage Ottawa public engagement website to gather residents' feedback on a potential vacant unit tax. Residents will have from February 22 until the survey closes on March 31 to provide feedback.

OTTAWA PUBLIC LIBRARY

Ottawa Public Library Branches are Now Open

On February 22, the Ottawa Public Library welcomed customers back inside branches across the City. The Bookmobile has also resumed offering a small collection for browsing at all its stops, as well as contactless returns and holds pick up.

I recently received confirmation that the Hunt Club-Riverside Park Community Centre will not be reopening to the public in the short term, which means the library kiosk service will not yet reopen. Library kiosk customers are encouraged to redirect their holds to other branches or the recently resumed Bookmobile stops. The Bookmobile offers holds pickup and return services and is equipped with WiFi. And depending on which vehicle arrives at each stop, there can be 3,500 to 5,000 items of newer material in every format available for your browsing pleasure.

Bookings available now for eligible residents to receive the COVID-19 vaccine

Bookings are now available for COVID-19 vaccinations for some Ottawa residents.

Residents who were born in or before 1941, or who are adult recipients of chronic home care, and who live in the following communities are eligible to receive their vaccine starting Friday, March 5:

- Emerald Woods
- Heatherington
- Ledbury
- Heron Gate
- Ridgemont

- Riverview
- Sawmill Creek

To confirm that you are eligible for vaccination, please visit Ottawa Public Health's <u>COVID-19 Vaccine Eligibility Screening Tool.</u>

If you are eligible, please call 613-691-5505 to book your appointment. Service providers can take your call between 7:30 am and 6 pm, Monday to Friday, and 8:30 am to 4 pm Saturday and Sunday. Service is available in multiple languages.


Walk-ins will not be accepted, so please call in advance to book your appointment.

We are asking residents who are not eligible for this week's vaccine pop-up clinics not to call this booking phone line, as it is only for eligible residents. Please help us keep phone lines open for those who are eligible to receive a vaccine.

Pop-up clinics will be operating in these locations. Dates and times will be confirmed when you make your appointment.

- Albion Heatherington Community Centre, 1560
 Heatherington Road
- Sawmill Creek Pool and Community Centre, 3380
 D'Aoust Avenue
- Assunnah Muslims Association Community Centre,
 1216 Hunt Club Road

Accommodations will be made for residents who need



help with accessibility and all sites are accessible. If you are a Para Transpo user, you can book your ride to the pop-up clinic like you would normally do. If a transportation option is not available to you, you can request a ride to and from the clinic when you book your vaccine appointment.

If you were born in or before 1941 or are an adult recipient of chronic home care and do not live in these neighbourhoods, you are not eligible for a vaccine at these pop-up clinics. This is due to the limited supply of vaccines. Additional pop-up clinics in more neighbourhoods will be announced next week.

Community clinics are also expected to open later in March for all other Ottawa residents who were born in or before 1941, or who are recipients of chronic home care, pending vaccine delivery. Booking for these appointments will begin in mid-March. More information will be available in the coming weeks on how to book these appointments. Please do not call the booking phone line regarding these appointments at this time.

Background

Due to the current limited supply of vaccine, those who are at the highest risk are being vaccinated first. Rates of COVID-19 in the neighbourhoods where residents are at highest risk of the virus are on average five times higher than in the rest of Ottawa. In some cases, they are 16 times higher. Risks for hospitalization and death are also higher. Limiting hospitalizations will help the whole community and protect our health care system.

Pending vaccine availability, vaccinations will be rolled out in the coming weeks to more neighbourhoods where residents are at the greatest risk of COVID-19.

Residents of all ages who are not yet eligible for the vaccine are encouraged to follow announcements on the City of Ottawa and OPH websites and social media channels, and from your local news media to learn when they can receive their vaccine.

The Ontario government has identified adults aged 80 and older and adult recipients of chronic home care as priority groups to receive COVID-19 vaccinations during Phase 1 of the vaccine distribution plan. Please refer to Ontario.ca for details on other priority groups within Phase 1 of the plan. Caregivers, partners or roommates who were born after 1941 are not eligible at this time.
